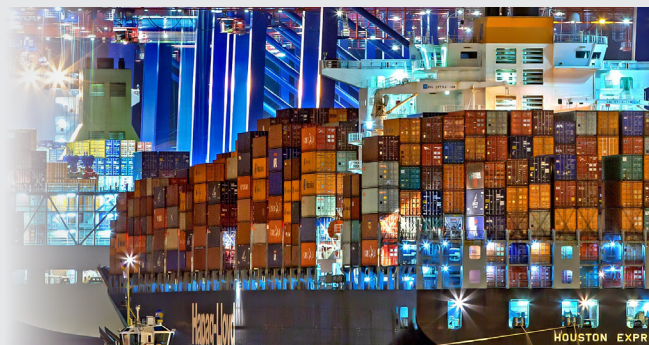

China's exports of medical devices increased 40,5 percent in 2020 compared to the previous year, reaching 18.138 billion US Dollars. Searching for suitable medical resources in a such huge market could be very difficult. The province Jiangsu is one of the most important hot spots for medical production in China. Together with Department of Commerce in Jiangsu and China Council for the Promotion of International Trade Jiangsu (CCPIT Jiangsu), fifty production companies from the province will be ready to meet importers, buyers, wholesalers and purchase managers from Europe and exchange ideas of their medical products.
